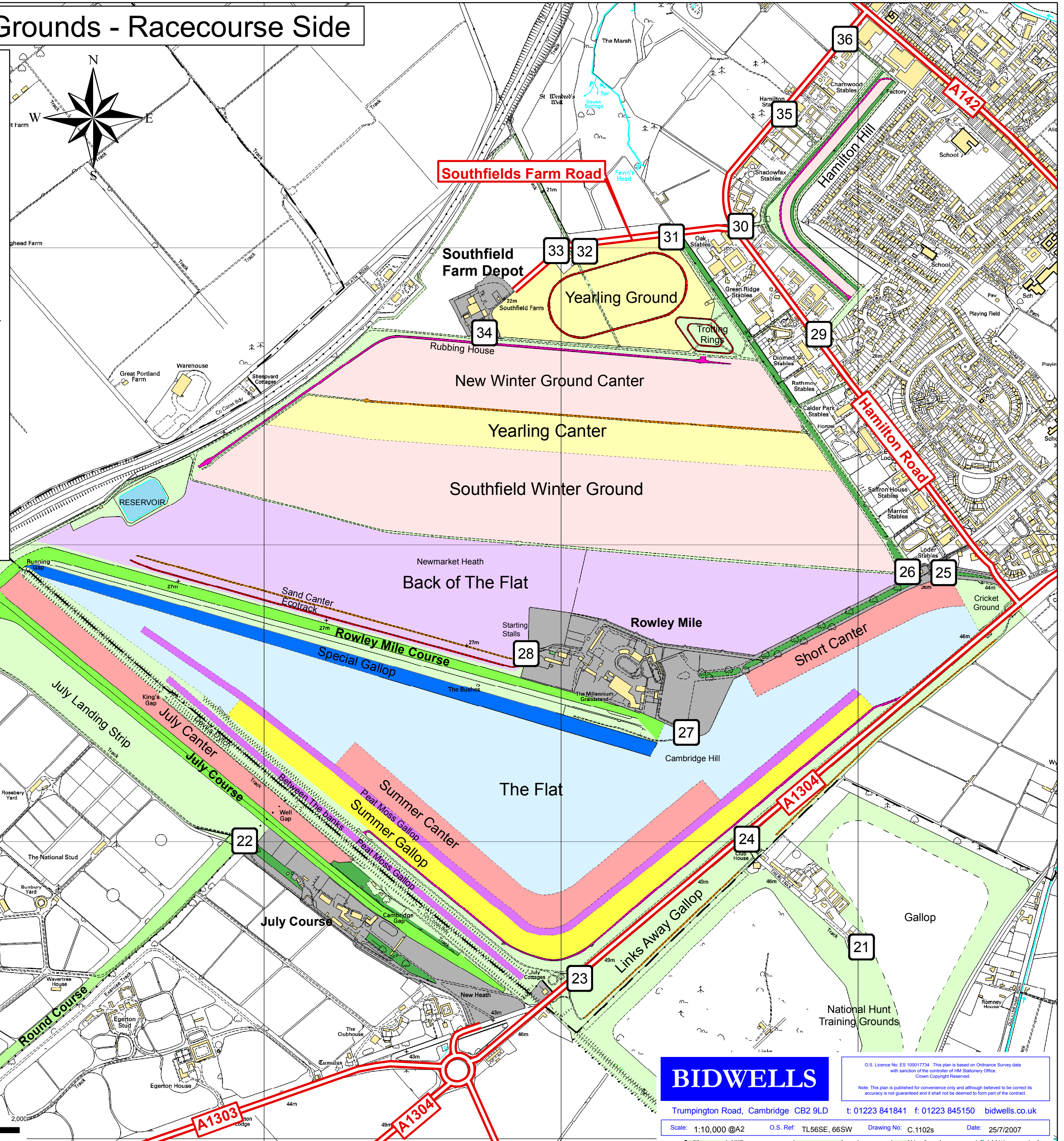
- Gate 21 - TL630 617, Links National Hunt Schooling Grounds

- Gate 23 - TL620 616, Horse Crossing Cambridge Road near Roundabout
- Gate 24 - TL626 620, Links Training Ground, Golf Club, Cambridge Road
- Gate 25 - TL633 629, Rowley Mile Racecourse, Cricket Pitch Entrance, Town End
- Gate 26 - TL632 629, Rowley Mile Racecourse Road near the Cottage on the Right, Double gates to Black Belt
- Gate 27 - TL624 624, Rowley Mile Racecourse, Members Car Park, finish of race track crossing
- Gate 28 - TL619 626, Rowley Mile Racecourse workshop at Greenhouse area. Far end of main stand stalls area.
- Gate 29 - TL629 637, Hamilton Hill off Hamilton Road opposite Diomed Stables
- Gate 30 - TL626 641, Hamilton Hill off Hamilton Road, off Gainsborough Stables
- Gate 31 - TL624 640, Southfields rear of Gainsborough Stables left hand side
- Gate 32 - TL621 640, Southfields round sand, near Newmarket Water Works left hand side
- Gate 33 - TL620 640, Exning Horse Walk near Water Works right hand side
- Gate 34 - TL617 637, Southfields Farm, Jockey Club Estates depot
- Gate 35 - TL627 645, Hamilton Hill off Hamilton Road, next to Hamilton stables
- Gate 36 - TL630 647, Hamilton Hill off Hamilton Road, Exning Road End.
